NATIONAL SENIOR CERTIFICATE (NSC) JUNE EXAMINATION</p> <p>The closing date for applications to the NSC June 2023 examination is: 08/02/2023. Application should be done at the District Offices.</p> <p>3. CONDITIONS FOR ENTRY AS PER THE REGULATIONS GOVERNING THE NSC JUNE 2023 EXAMINATION</p> <p>3.1 Candidates can only register for subjects which they were registered for in any November examination.</p> <p>3.2 Candidates who were absent with a valid reason (medical unfit, death in the immediate family or other special reasons*) from one or more external question papers, may register for the NSC June examination.</p> <p>3.3 Candidates who want to improve their overall achievement status, or only want to improve the achievement of a subject, may register for the NSC June examination.</p> <p>3.4 In the case where a candidate was absent for one or more papers in the November exam with a valid reason, the candidate has to write all the papers for the registered subject(s).</p> <p>3.5 In a case where an irregularity is being investigated, provisional enrolment for NSC June examination may be granted to the candidate concerned, pending the outcome of the investigation.</p> <p>3.6 Candidates who were unable to write or complete one or more of the NSC November examination question papers for reasons other than illness/injury or death in the family, may apply to write the NSC June examination, provided that a written report is submitted by the principal of the school to the Head of the assessment body.</p> <p>4. Result queries should be submitted for investigation within 30 days after the release of results.
