

<p>1. RE-MARK/RE-CHECK OF EXAMINATION SCRIPTS</p> <p>1.1 Candidates may apply at the prescribed fee for the re-mark/re-check of their examination scripts. Registration for this must be done at the District/Regional Office, which serves the school the candidate has attended. Application must be done once only.</p> <p>1.2 RE-MARK and RE-CHECK of scripts.</p> <p>1.2.1 Closing date for applications: 29/01/2025 Online registration will be available on www.eservices.gov.za. Check the Education website for more details.</p> <p>1.2.2 Fees for re-mark and re-check of scripts per subject: RE-MARK: R120.00 RE-CHECK: R30.00</p> <p>1.3 VIEWING of scripts (may only be done after a re-mark or re-check of results).</p> <p>1.3.1 Closing date for applications: 7 days after release of re-mark or re-check results.</p> <p>1.3.2 Fees for viewing: R230.00</p> <p>2. NATIONAL SENIOR CERTIFICATE (NSC) JUNE EXAMINATION</p> <p>2.1. The closing date for applications to the NSC June 2025 examination is: 07/02/2025. Application should be done at the Circuit Offices.</p> <p>2.2. CONDITIONS FOR ENTRY AS PER THE REGULATIONS GOVERNING THE NSC JUNE 2025 EXAMINATION: The NSC June 2025 examination IS OPEN to all candidates who wrote NSC since 2008. Candidates can <u>only</u> register for subjects which they were registered for in any November examination.</p> <p>3. NATIONAL SENIOR CERTIFICATE (NSC) NOVEMBER EXAMINATION</p> <p>3.1. This examination is open for NSC PART-TIME REPEATERS who may wish to improve some of the subjects they wrote in the previous NSC examinations. Application should be done at the Circuit Offices.</p> <p>3.2. The closing date for applications to the NSC November 2025 examination is 15 March 2025.</p> <p>3.3. A candidate who wishes to register for a new subject not offered previously may register for November examination on condition that:</p> <p>3.3.1. The candidate arranges with a full-time school registered with the Limpopo Department of Education as an examination centre, for assistance in compiling internal assessments (SBA/Oral/PAT). The school must issue the candidate a commitment letter.</p> <p>3.3.2. The candidate attaches a commitment letter from the full-time centre to the application form.</p>	<p>1. <p>4. COMBINATION OF NSC RESULTS</p> <p>A candidate may combine subjects from two or more NSC examinations (e.g. from 2019 to 2024) in order to improve his/her results.</p> <p>4.1. The application must be submitted to the Province in which the last examination was written.</p> <p>4.2. The candidate can apply for combination if there is an improvement in at least one subject.</p> <p>4.3. Procedure for applying:</p> <p>4.3.1 Apply for combinations at the District Examinations Office nearest to you, OR the Provincial Registry Office, 113 Biccard Street, Polokwane.</p> <p>4.3.2 Complete the application form using black ink.</p> <p>4.3.3 Make the necessary payment, EFT or bank deposit (banking details are on the application form).</p> <p>4.3.4 Submit your completed application form to the District Examinations Office or Provincial Registry Office, together with:</p> <p>4.3.4.1 copies of statements of results to be combined,</p> <p>4.3.4.2 copy of ID, and</p> <p>4.3.4.3 proof of payment.</p> <p>4.4. Once received and approved, the application will be processed, and the combined statement will be available for collection at your District Examinations Office within two (02) working days.</p> <p>4.5. Follow-ups on the progress of the application may be made by contacting the office where the application was made. The contact details are indicated below.</p> <p>5. CORRECTION AND/OR CHANGE OF PERSONAL DETAILS ON THE 2024/11 STATEMENT OF RESULTS</p> <p>Should any personal details on the 2024/11 Statement of Results be incorrect (e.g. spelling of names, incorrect Identity number or Date of Birth) or should a candidate wish to make a change to the personal details given at registration (e.g. a change in surname) the following procedures apply:</p>	<p>5.1 Documents required:</p> <p>5.1.1. Confirmation letter from the principal;</p> <p>5.1.2. Certified copies of the legal documentation used during registration (Identity document/Birth Certificate/Passport)</p> <p>5.1.3. Original 2024/11 Statement of Results;</p> <p>5.1.4. In case of a complete change of personal details: confirmation letter from the Department of Home Affairs, and copies of old and new Identification documents.</p> <p>5.2 Clear indication should be made on the Original 2024/11 Statement of Results, of the error or change to be effected (supported by the accompanying documentation as listed in 5.1. above).</p> <p>5.3 Request for correction and/or change should be made by submitting the documents to the nearest District Examinations Office or Provincial Examinations Office, 113 Biccard Street, Polokwane. Requests for changes must be made on or before 31 January 2025. NO LATE requests for corrections will be entertained due to processes leading to certification.</p> <p>6. CORRECTIONS/CHANGES ON CERTIFICATES:</p> <p>6.1 Once certificates are issued, a candidate may apply for corrections WITHIN 6 MONTHS after issue or within a year after the date of the exam: i.e. the 2024/11 candidates have until 31 October 2025 to apply for such corrections. These changes refer ONLY to information that was not captured correctly at the time of registration.</p> <p>6.2 For legal changes on the certificate, Form E-26 (Change of Particulars) application form must be requested from District Examinations Office or Provincial Registry Office.</p> <p>6.3 ALL APPLICATIONS for changes done after the first certification are paid for by the applicant.</p>
